Attached you will find the 2023 application. Craft vendors will be charged \$150 per space. Edible vendors will be charged \$175 per space. Food vendors will be charged \$200 per space. These are the same fee amounts as previous years. Each booth space is approximately 10' x 10'. You can start setting up at 7 am. All set up must be completed by 9 am. All vehicles must be removed from the Street Fair area by 9 am. You must remain at the fair until 5 pm. Should you choose, I will allow any vendor to stay until 9 pm without further charge.

A craft vendor is one who sells crafts, etc. An edible vendor is one who sells pre-packaged food items. A food vendor is one who prepares food at the event for sale. If you are interested in reserving your space for this year, please complete the attached application and mail it to:

You are also responsible for obtaining insurance that lists Town of Steilacoom <u>AND</u> Steilacoom Chamber of Commerce as additional insured. NO food vendor application will be processed without the insurance declaration attached to it.
